(57) **ABSTRACT**

According to one embodiment, there is provided an image
forming apparatus including a fan and a duct. The fan and the
duct are provided in a housing. If the fan is driven, the duct
guides the air flowing into the housing from an intake port of
the housing toward components in the housing. The duct
includes a bent section that changes a flowing direction of the
air. The bent section includes holes.
