(57) **CLAIM**

We claim the ornamental design for an automated analyzer, test cartridge, and sample collection device for analyte detection, as shown and described.

DESCRIPTION

FIG. 1A is a top, front, and left side perspective view of a first embodiment of an automated analyzer, test cartridge, and sample collection device for analyte detection;

FIG. 1B is a left side view thereof;

FIG. 1C is a right side view thereof;

FIG. 1D is a top view thereof;

FIG. 1E is a bottom view thereof;

FIG. 1F is a front view thereof;
