(57) **ABSTRACT**

A modular garment includes a sleeved jacket and a vest that
may be worn by a first responder. The sleeved jacket is con-
structed for use in some emergency circumstances, including
technical rescue operations. Portions of the jacket, including
at least portions of the sleeves, may be constructed to satisfy
more stringent garment standards, such as garment standards
for structural firefighting. A vest may be worn over the
sleeved jacket to produce a combined jacket suitable for use
as turnout gear in structural firefighting.
