


[57] ABSTRACT

Cosmetic, dermatological and dietary compositions for treatment of aging of the skin are provided that contain an extract of the Sacred Lotus (*Nelumbo Nucifera*) seed as an active anti-aging agent in a suitable carrier or vehicle along with methods of treatment to reduce signs of aging such loss of elasticity, age spots, acne, blemishes, enlarged pores, fine lines, wrinkles and to promote overall younger looking skin by using said compositions.




NECK/BEFORE
