(57) **ABSTRACT**

Described is a syringe carrier comprising a body adapted to  
receive a barrel of a syringe. The body includes an enlarged  
distal portion having a diameter greater than a diameter of the  
body. The enlarged distal portion has one or more resilient  
barbs adapted to engage a circumferential gap between the  
barrel of the syringe and a needle shield covering a needle of  
the syringe.
