(57) **ABSTRACT**

Golf clubs according to at least some example aspects of this
disclosure may include a golf club head and a shaft configured
to engage with the golf club head which includes a grip
engaged with the shaft. Further, the golf club may include a
monitoring device, which includes a sensor and a transmitter.
Additionally, the monitoring device may be configured to
determine data related to the characteristics of a golf swing.
Further, the monitoring device may be configured to transmit
the data related to the characteristics of a golf swing to a
remote computer.
